I, Charles Williamson, having first been duly sworn, do hereby state as follows:

1. I make this affidavit based upon my own personal knowledge.
2. I am a partner in the law firm of Kell, Alterman & Runstein, LLP. I have been practicing law in Portland, Oregon since 1970. I am familiar with the billing practices and rates of law firms that bill by the hour.
3. I am personally familiar with the nature of Kafoury & McDougal's law practice. I periodically have lunch with them and we mutually discuss cases that we have pending.
4. I am the former president of the Oregon State Bar.
5. Over the years I have learned of many of the successful trials done by Kafoury & McDougal. They have consistently repeated their successes over the years. 7. The above rates are particularly appropriate for Kafoury & McDougal in a case involving civil rights as the firm is known and well respected for its advocacy of politically charged


cases and their successful results in trials of such a nature. Although Kafoury & McDougal were defending this case, it was of a similar nature as it involved vindicating protestors' activities.

I make the above statement based upon my personal knowledge.



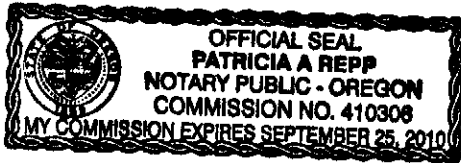


