("Durkee") appeared before The Honorable Michael M. Mosman for oral argument on their Special Motions to Strike Plaintiffs' Complaint. After reviewing the submissions of the parties and hearing the oral argument of counsel, Judge Mosman granted the Special Motions to Strike filed by defendants PETA, IDA, Rosell, and Durkee, pursuant to ORS 31.150, by Order dated June 19, 2007. Now, therefore, pursuant to Fed. R. Civ. P. 54(b),

IT IS HEREBY ORDERED AND ADJUDGED that plaintiffs' Complaint be dismissed in its entirety as to defendants PETA, IDA, Rosell, and Durkee, and the clerk is directed to enter such final judgment forthwith.

It is expressly determined by this Court that there is no just reason for delay in the entry of this judgment until final determination as to all the parties in the above-captioned matter, for the reasons and grounds as follows: this Court's ruling on the above-named defendants' Special Motions to Strike disposed of all the claims against them in this matter.
